We urge all members to be socially responsible and stay safe - wishing all members a prosperous and abundant tiger year ahead!





PUBLIC TRANSPORT FARES INCREASE

Public transport fares for buses and trains have increased from 26 Dec 2021. Prices for monthly concession and travel passes will remain unchanged. Households with monthly household income of not more than \$1,600 can apply for Public Transport Vouchers (PTVs) valued at \$30 each, at Community Centres/Clubs. PTVs can be used to top up fare cards or buy monthly concession passes and must be redeemed by 31 Mar 2023.

CLIMATE FRIENDLY HOUSEHOLDS PROGRAMME



All 1-, 2- and 3-room HDB households are eligible to receive eVouchers to switch to climate-friendly refrigerator, shower fittings or lights. Each household can receive:

- One \$150 e-voucher to offset the cost of a refrigerator,
- One \$50 e-voucher to purchase shower fittings, including installation costs if required,
- One \$25 e-voucher to purchase LED lights



Refrigerators and shower fittings must have 3-ticks and above to show that they are energy efficient and climate friendly. The vouchers can be used to purchase eligible products at major retailers island-wide and expire 31 Dec 2023. Visit climate-friendly-households.gov.sg for more details.

\$100 CDC VOUCHERS FOR EACH HOUSEHOLD

Each Singaporean household can now claim \$100 CDC vouchers which can be used at any participating hawkers and heartland merchants identified by the CDC voucher decal.

Only one member of each household will need to visit the website go.gov.sg/cdcv to claim the voucher with their Singpass which can then be shared digitally with other household members.

Assistance will be available at community centres and clubs to guide residents on how to claim the vouchers, provide help to set up or reset Singpass, and print hardcopy vouchers, if needed.

MORE DENGUE CASES EXPECTED

National Environment Agency (NEA) expects the number of dengue cases to surpass that of last year's "relatively low" tally of 5,238. Low population immunity to a particular serotype, increasing mosquito population and continued work-fromhome arrangements are factors NEA attributes the increase to.

24 active clusters have been reported including four large clusters at Cleantech Loop, Jalan Bangau, Denham Close/Dunearn Road/Hua Guan Avenue, and Dunearn Road. More inspections have been carried out by NEA which

have resulted in actions taken including Stop Work Orders and contractors charged in court for repeat offences. NEA urged the public to take steps to prevent mosquito breeding such as removing stagnant water and overturning pails.



COVID-19 VACCINATION FOR CHILDREN AGED

5 TO 11

before 7pm.

The paediatric dose of PfizerBioNTech/ Comirnaty vaccine is now available for children aged 5 to 11. The full vaccination will require two doses taken at least 21 days apart.

CHILDREN AGED 12 TO 17 TO GET BOOSTER SHOT

From 14 Mar, children aged 12 to 17 will need to get a booster shot within 270 days of receiving their second dose of the COVID-19 vaccine, in order to maintain their fully vaccinated status. Parents or guardians of these children will receive an SMS with a personalised booking link to the mobile number that they had registered to provide consent and book their child's booster vaccination appointment.

Currently, those 18 years and above are required to take a booster shot within 270 days of completing their primary vaccination series in order to maintain a fully vaccinated status against COVID-19 from 14 Feb. Those who have recovered from

their primary series vaccination will not be required to take the booster dose at this point in time.

Automate Your Savings

Save automatically by choosing to set aside a fixed amount every time you receive your pay check. Keep this account separate where you can't access it easily so you don't have to think about it or see the money, reducing the temptation to spend it.

Most banks allow for this function. SGS Co-Op Specific Deposit also allows for monthly contribution through salary check-off and pays interest on your savings.



Budget Your Expenses

Set a fixed monthly budget for daily expenses such as groceries, meals and transport. Review your past year expenses and decide how much this budget needs to be. If you foresee higher expenses in the month ahead, choose to save more in the months before rather than dip into savings. Practicing this habit of prudence will allow your savings to accumulate and grow.



Pay Down Debt

If you can, use any extra money to pay down some debt such as home or car loans. This reduces the total amount of interest you have to pay and allows you to clear the debt sooner. In the long run, it can save you hundreds or thousands of dollars.
