# COUNTING OUR BLESSINGS

Dear members,

We are off to a tumultuous start in 2020. Covid-19 continue to dominate the news headlines, our social media feeds, our mobile chat groups and in our thoughts.

We have seen the rapid spread from person to person and it's potential to be deadly, especially if our vulnerable elderly are infected. Global scientists are in a race against time and authorities move as fast as possible to channel funds and resources to expedite the development of a cure.

We are dealing with many unknowns following the discovery of this new coronavirus. Nonetheless, it continues to strike fear into our hearts when fake news and rumours spread on social media, dramatizing the situation and scaring people to act irrationally. Each of us has a role to play. We have to band together and cop down on these irresponsible behaviours. Only then, we do not over stretch our precious resources and our healthcare colleagues can focus their energies on healing our sick.

Recent news report that experts believe the situation may linger until the end of the year. If so, we will need to focus on recovery, so that we may bounce back quickly. Instead of assigning blame, this is the time we need to show our solidarity and band together in our fight against the virus outbreak.



The Government has announced that as the virus spreads globally and affects more countries, Singapore will have to ramp up and implement other measures aside from social distancing measures such as isolating patients and issuing quarantine orders for close contacts.

As socially responsible individuals, we can take some basic measures. For example, we should monitor our own health and not go out to public areas when we are sick. We need to respect quarantine and stay-home notices.

Singapore has been held up as an example for the world to follow in the management of the outbreak. The measures are not by chance but a deliberate attempt to co-operate and co-ordinate across ministries to implement various measures.

Hence, I would like to take this opportunity to salute all our members and colleagues fighting in the frontline in this dynamic Covid-19 situation. Your dedication and commitment to your jobs assure a safer country for every one of us.

## 95 GOING ON 100...

I hope by now, you have realised that our SGS Co-op has reached yet, another milestone. This is our 95th year and is marked by the new emblem in all our communications. It is no easy feat and not natural for a co-operative to continue to do well over

decades. It is the dedication of our staff and committee of management who steadfastly steered our society onto the progressive road and preserve our savings for a better insured future.

Members will be pleased to know that we have been monitoring the situation and have been keeping our eyes peeled for good investment opportunities. While Covid-19 has an economic impact and property rentals are affected (including ours), we have managed to snag a new property in Peace Centre at a steal – the unit next to our office and which we are considering to be used for our expansion to better serve more members. This brings the total units we own in Peace Centre to 3 and the total units we own in Singapore to 9, with a combined estimated book value of \$13 million.

We are in the midst of publishing our Annual Report in review of our last financial year and this will be made available for all our members. While we have seen a slowing in members' demands for loans, we believe that the profits we gained from 2019 will see us through. Members will also receive your annual statement of accounts and can write to us if they have not.

Especially in uncertain times like these, these steady low-risk forms of insurance must surely bring us some comfort and calm as we watch the Covid-19 storm pass over. For

that reason, we remain hopeful that we will be able to come together and commemorate this significant milestone at the end of the year, during our Gala Dinner to mark our 95th year as a society.

To capture our journey and to pass on our heritage, we intend to encapsulate our stories in an e-book to share the trials and tribulations our society has seen and experienced since the formative years of Singapore. Where stories are preferably told through visuals, we will also consider producing a video clip for our future generations to remember. These initiatives will be announced when they become available; so please keep a look out for these news.

# Key Highlights from Singapore Budget 2020



Amid challenging global uncertainty, the government has announced a slew of measures to help cushion short-term effects as well as long-term measures on growing and transforming the economy over the next three years. Here's what you need to know:

## 1. NO increase in GST

GST will not increase and will remain at 7% in 2020 and 2021.



## 2. SkillsFuture Credit for Upskilling and Pursuing New Interests

All Singaporeans aged 25 and above will get a one-off SkillsFuture Credit top-up of \$500. Singaporeans aged 40 to 60 will receive an additional one-off \$500 credit which can be used for career transition programmes at Continuing Education and Training (CET) centres. This amount will be credited into your SkillsFuture account from 1 October 2020. You can log in and view the range of programmes and courses available to sign up for at [www.skillsfuture.sg](http://www.skillsfuture.sg). Want to pick up a new skill or learn more about data analytics? Here's your chance! Don't wait too long as this credit will expire in 5 years.



## 3. \$100 top-up in PAssion cards for older Singaporeans

All Singaporeans aged 50 and above in 2020 will receive \$100 top-up in their PAssion Card to alleviate living costs.



## 4. \$1.6 billion Care and Support Package

Households will receive a one-off cash payout of \$300, \$200 or \$100 depending on their income. Those who own more than one property will receive \$100, regardless of their income. Parents with one or more Singaporean children aged 20 years and below in 2020 will each receive an additional \$100 in cash

## 5. HDB Households receive one-off special payment to offset utilities bills

GST Vouchers given in the form of U-Save provides families with quarterly rebates to offset their utilities bills. In Budget 2020, the government announced a one-off special payment for all eligible HDB households with additional rebate for households with five or more family members. This will be paid out in the coming months – April, July, October and January next year.

## 6. Rebate for Service and Conservancy Charges

Eligible Singaporean households living in HDB flats will receive rebates to offset their Service and Conservancy Charges (S&CC) spread out over FY2020. Depending on their flat types, households will receive rebates of up to 3.5 months.

# NEWS *from Around* Singapore

## SPECIAL REPORT: COVID-19

Our news and social media feeds have been flooded with stories about Covid-19 recently as the disease outbreak hit our shores. In such uncertain times, fear has taken a grip on people with social media sensationalising news and exacerbating the situation.

There have been reports on xenophobic attacks on East Asian people including a Singaporean student being beaten up in London, panic buying of toilet paper and empty supermarket shelves, opportunistic hawkers hiking prices of sanitisers and face masks. As our health authorities fight to control the situation, fake news and rumours are unnecessarily spreading fear and panic through social media.

How do we differentiate fact from fiction?

Here are some key facts you should know about the Covid-19 situation...

### Get the Numbers Right


Our Ministry of Health (MOH) has been keeping the public informed about the situation with regular reports published on its website at [www.moh.gov.sg/covid-19](http://www.moh.gov.sg/covid-19).

While the virus was first reported from China, the number of new cases outside of China have surpassed that in China. To find out about the numbers worldwide, visit World Health Organisation (WHO) site at [www.who.int/emergencies/diseases/novel-coronavirus-2019](http://www.who.int/emergencies/diseases/novel-coronavirus-2019). The Situation Reports tracks data reported by national authorities daily and keeps track of the Covid-19 global situation.



### What is Covid-19?

Covid-19 is the infectious disease caused by the most recently discovered coronavirus first reported in Wuhan, China in December 2019. In humans, the disease is known to cause respiratory infections ranging from the common cold to more severe diseases such as Middle East Respiratory Syndrome (MERS) and Severe Acute Respiratory Syndrome (SARS). People can catch Covid-19 from others who have the infection which is believed to be spread through small droplets from an infected person. However, WHO is assessing ongoing research on the ways Covid-19 is spread and will continue to share updated findings on its website.



### Head to GP or hospital A&E immediately?

If you have recently travelled overseas, and are feeling unwell with a fever, or respiratory symptoms (such as cough, runny nose), please seek medical attention promptly.

You can go to any of the Public Health Preparedness Clinics (PHPCs), as well as polyclinics. Find a PHPC near you at [www.phpc.gov.sg](http://www.phpc.gov.sg). All cases fulfilling the suspect case definition seen at various healthcare settings will be reported to MOH immediately and referred to hospitals for further assessment and treatment.



## Quarantine Order (QO) v.s. Leave of Absence (LOA) v.s. Stay-Home Notice (SHN)

There are various restrictions for those people in Singapore who may be identified as a potential carrier of the virus. If you or your family member have been issued one of these orders, you can find out more about how it affects you and what you need to do via MOH's website.

Quarantine Order (QO)	Stay-Home Notice (SHN)	Leave of Absence (LOA)
<p>QO is a legal order issued to individuals under the Infectious Diseases Act and thus have legal force with severe penalties for non-compliance.</p> <p>A QO is issued to <u>quarantine or isolate an individual</u> who is, or is suspected to be, a carrier of an infectious disease, or a contact of a person confirmed to have an infectious disease. This is with the aim of limiting the spread of the virus in the community. Quarantine usually occurs in the home but can also be served in dedicated Government Quarantine Facilities (GQFs) or hospitals, should the individual not have suitable accommodation in Singapore.</p>	<p>Stay-Home Notice (SHN) is stricter than the LOA regime.</p> <p>Those placed on SHN will have to <u>remain in their place of residence at all times</u>, and should not invite visitors to their residence.</p>	<p>Leave of Absence (LOA) is a precautionary measure.</p> <p>We urge those who are on LOA to be socially responsible and comply with the LOA, to prevent possible transmission of infections. Persons on LOA should remain in their residences as much as possible, minimise visitors and maintain good records of persons with whom they come into close contact.</p> <p>Persons on LOA may leave their residences for daily necessities or to attend important matters, but they <u>must minimise time spent</u> in public spaces and contact with others.</p>
