#### INTEREST RATE FOR FIXED DESPOSITS INCREASED

Fixed Deposit interest rates for new and renewal placements will be increased to 2% per annum with immediate effect from November 2022. Specific Depost savings rate remains unchanged.





The essence of our society is our members – SGS Co-Op was formed with a focus to provide financial security to Public Officers. What better way to learn about the evolution of our society than from the perspective of one of our oldest members.

Meet Mr. Yeo Cheng Kim, aged 85, who has been a member of SGS Co-Op for the last 62 years and counting...! This meant that he first joined the Co-Op when he was aged 23 in the 1960s, soon after joining the public service.

In 1957, he secured a job in the Public Works Department, established by Singapore's thencolonial government, with a monthly salary of around \$175. Coming from a poor family, he has always been very prudent with his earnings – giving them all to his mother for household expenses back then.

When he first heard about SGS Co-Op, he thought it was a good way for him to grow his savings and signed up readily. A few years later, the savings he earned under the society allowed him to combine with his wife's savings to buy their first marital home in Mayflower Gardens for around \$27,500.

Looking back, he felt lucky he joined the Co-Op early which



life. To this day, Mr. Yeo strongly believes in cultivating good saving habits. He shares his thoughts here...

## Could you briefly share about your past as a public officer?

I mainly held administrative posts in the public service. I worked in different offices such as the Ministry of Home Affairs, the Registry of Societies, and the Vigilante Corps for a while. The longest I served was probably at the Central Narcotics Bureau (CNB).

## How did you first hear about SGS Co-Op?

My first supervisor was a member of the SGS Co-Op and he introduced the Co-Op to me. I just started working then, and wanted to have financial security. He told me how being a member "forces you to save"

through regular deposits which accumulate interest as well. I thought that was a great idea so I joined!

I also found out that we could also get loans through the Co-Op – which was very helpful. I still remember buying my very first scooter using the Co-Op's loan facility. My scooter helped me cut my travelling time to work by half, which made it a great investment!



# How does being a member of the SGS Co-Op help public officers?

For me, having to put aside your income every month, forcing you to save, is a very good idea. It has helped me become financially stable because my savings and earnings grew. SGS Co-Op also gives good and stable returns which is a bonus in addition to the interest on my savings. Over the years, as we save and when we have extra money, my family would go on holidays regularly. So I think this habit of being prudent and spending within your means lays a good foundation.



## What does it mean to be financially secure?

Being able to provide for your family is important. For me, fundamental habits are really important such as being prudent, saving as much as possible for a rainy day, and I don't believe in splurging. Occasionally, I do spend more when dining out with my family during birthdays and special occasions. I would also meet up with my friends and I would spend a bit more.

However, I still prefer cooking simple meals at home. If you eat out all the time, it could add up to a lot. I don't like too much clutter so I don't shop a lot. For example, I only need one pair of good walking shoes and only have that one pair! I don't drink, smoke, or gamble either. My late wife and I were good savers. We would keep our money in time deposits other than the Co-Op. All these small habits accumulate to provide me with stability and security.

## Any financial tips you would like to share with younger members?

It is very important to be prudent and to spend within your means. If you find a stable instrument, like the coop, and start with the good habit of forced savings, in the long run, it will help you become financially stable.

Think twice before you spend – figure out what is essential to spend and what would be frivolous. You can buy more only after you saved and when you have excess money!

# Any wish or hope that you would like to see in SGS Co-Op's next 100 years?

I didn't join any other societies so I can't make a comparison but I would say that the Co-Op must be doing a good job for it to continue being around for so many years!









# Annual Co-Operative Leaders' Conference ACLC 2022

This year, the Singapore National Co-operative Federation (SNCF) organised the Annual Co-operative Leaders' Conference (ACLC) at Kota Kinabalu, Sabah in Malaysia from 5 to 8 Nov 2022.

As the apex body of Singapore's Co-operative Movement, SNCF holds the ACLC every year which sees co-operative leaders around Singapore congregating and sharing lessons so that co-operatives in Singapore can pivot better in the future.

This year's theme "Becoming More Resilient" calls for co-operatives to future-proof and ready themselves for

the challenges ahead. This would also be the first year where ACLC takes place overseas since the pandemic upended travel plans around the world.

During the conference, salient topics across cybersecurity and crisis communication were discussed, giving participants an oversight of key trends and tips on navigating challenges in today's landscape.

During the Forward Singapore exercise, co-operative leaders brainstormed together to map out a shared vision of the Co-operative Movement – identifying challenges and opportunities for the Movement as well










as built consensus on the social compact and how cooperatives play a key role in Singapore's future.

Forward Singapore is a collective effort led by Deputy Prime Minister Lawrence Wong, working in partnership with Singaporeans, to review and refresh Singapore's social compact and set out a roadmap for the future. Singapore's social compact is an expression of our shared values and norms, and determines the roles and responsibilities of the Government, the community, businesses and individuals in society.

It was not all work at ACLC – time was set aside for networking, socialising and having fun to bond with fellow co-operators. Working with the Sabah Tourism Board for the first time, conference participants got a fascinating insight into Sabahan culture, visiting the Mari Mari Cultural Village and were blown away by an enthralling ethnic performance before the conference wrapped up.

Who knows? Perhaps the next members' tour will be to visit Sabah, Malaysia.

## UPTO \$700 IN DECEMBER CASH PAYOUTS

About 2.5 million Singaporeans will get up to \$700 in cash in December as part of government packages to offset the impact of the GST hike and help people cope with rising costs. The \$700 will come from two separate payouts.

Under the one-off Cost-of-Living special payment, about 2.5 million adult Singaporeans will get up to \$500. Under the Assuarance Package (AP) Cash Payout, up to \$200 will be given to each eligible adult Singaporean.

Citizens can check their eligibility for the cash payouts at the Assurance Package official website (www.govbenefits.gov. sg) by logging in with Singpass. Citizens who have linked their NRIC to PayNow will receive the payments earlier, starting from 5 Dec. Those who have not linked their NRIC or provided their bank account details can withdraw the handouts at OCBC ATMs with instructions sent via Singpass app, SMS or mail.

#### VISIT 4 NEW TASMANIAN DEVILS AT SINGAPORE NIGHT SAFARI

Crumpet, Snickers, Jesse and Panini are four female Tasmanian Devils that are now staying at the Night Safari Singapore. Under the recommendation of the Species Management Programme, they were transferred here to ensure the long-term viability and sustainability of species populations under human care

of Nature's Red List, with their population dropping by at least 80 per cent due to a transmissible cancer highly contagious a mong their population. These four will hopefully be ambassadors to help raise awareness about the plight of their wild counterparts.

## TRIALS TO SUPPORT ELECTRIC MOTORCYCLES


To support more electric motorcycles on the road, two electric motorcycle and battery swapping regulatory sandbox trials have been approved in Singapore in September. The trials will use electric motorcycles and battery swap stations for last mile deliveries and conduct pilots using electric motorcycles and a combination of centralised charging, battery swap and storage.

These trials will test the viability of technologies to grow the electic vehicle ecosystem here. To support the growing sector, Land Transport Authority (LTA) will also be developing skills training courses to upskill and trained workers equipped to work on the safety and maintenance of electric vehicles as more of these are used in the future.

Tips from SGS Co-Op

# WHAT YOU NEED TO KNOW ABOUT FINANCIAL EMBARRASSMENT

Every public officer has a duty to maintain high standards of personal conduct and integrity. This requires public officers to declare their financial standing when they first join and every year thereafter or whenever their unsecured financial liabilities exceed 3 months' salary.



This declaration ensures that public officers remain in good financial standing and helps the public service know when an officer becomes vulnerable due to financial embarrassment. The intention is meant to protect the officer and the Public Service.

#### What is Financial Embarrassment?

This happens when an officer:

- Becomes an undischarged bankrupt
- Signs a promissory note of indebtedness
- Defaulted repayment of loans or have unsecured debts and liabilities exceeding 3 months' salary

#### **Types of Loans Allowed**

Public officers need to be careful and are specifically limited to loans from these categories:

- Secured loans and credit facilities such as housing and car loans
- Special category of unsecured loans and credit facilities such as education-related loans, renovation loans, loans from co-operatives
- Unsecured loans, credit facilities and liabilities must be capped at 3 times monthly salary e.g. credit card and personal lines of credit.

Public officers are **not** allowed to borrow from a money lender.
